A part-time holder of public office or appointment shown in column 1 and 2 of the following table shall be entitled to the per annum remuneration specified in column 3 unless specifically identified as a per diem rate. *Note: In the majority of cases the actual remuneration determined by the Tribunal will fall below the Maximum of the range.*
