Statement Number 107

Part-Time Holder of Public Office ACT Forests' Board of Advisors

Background

Paragraph 10(1)(t) of the *Remuneration Tribunal Act 1995* provides for the Tribunal to inquire into, and determine, the remuneration and allowances to be paid, and other entitlements to be granted to a person holding an office or appointment, or a class of offices or appointments, specified in an instrument given to the Tribunal by the Chief Minister.

The Chief Minister has referred the office of the Members of the ACT Forests' Board of Advisors under paragraph 10 (1) (t) of the Act.

Tribunal Consideration

The Tribunal compared the responsibilities of the Members to positions on other boards and committees using the Part-time Holders of Public Offices ACT Remuneration Guidelines.

Considering these comparisons and based on the information provided, the Tribunal has determined that the Members met the criteria for the Group 2, Level 1 Category.

The Tribunal recognised that remuneration for the Members should reflect the high degree of financial and industry expertise required of these appointments.

The position of Chair was not referred to the Tribunal as a public servant holds this position, and therefore it does not attract separate remuneration.

Tribunal Decision

The Tribunal has set the rate at \$12,500 per annum for the Members.

The Tribunal has also determined travel entitlements by reference to "All other offices" in Determination 98 – Travel Allowances.

The date of effect is 19 July 2002.
