### Part-Time Holders of Public Office

### ACT Insurance Authority Advisory Board

#### Background

Section 10(1)(r) of the *Remuneration Tribunal Act 1995* provides for the Tribunal to inquire into, and determine, the remuneration and allowances to be paid, and other entitlements to be granted to persons appointed to certain Part-Time Public Offices.

The acting Chief Minister has referred the statutory office of Member of the ACT Insurance Authority Advisory Board for such determination. There will be no Chair of the Board.

#### Tribunal Consideration

The Board is a statutory body established under the *Insurance Authority Act 2005* and replaces the ACT Insurance Authority Board that was established under the repealed *Insurance Authority Act 2000*. The new Board will commence operation on 4 July 2005.

Members of the Board will have similar responsibilities as the members of the previous Board.

#### Tribunal Determination

The Tribunal has determined that the ACT Insurance Authority Advisory Board be classified as Group 2, Level 1 and that remuneration be \$16,650 per annum for Members.

The date of effect of the Determination is 4 July 2005.

**ACT Insurance Authority Advisory Board**

**The Tribunal determines as follows:**

Pursuant to section 10(1)(r) of the *Remuneration Tribunal Act 1995* the Remuneration Tribunal has inquired into the remuneration and allowances to be paid, and other entitlements to be granted to the persons holding the Part-Time Public Office of Member of the ACT Insurance Authority Advisory Board and determines as follows: -

1. That Attachment 1 of Determination Number 163 made in 30 December 2004 be varied by amending Group 2, Level 1 by replacing ACT Insurance Authority Board with the following: -

Column 1	Column 2	Column 3
Name	Office	Rate
ACT Insurance Authority Advisory Board	Members	\$16,650

2. In respect of domestic travel, economy class travel for trips or part trips less than four hours in the air and business class for all trips or parts of trips exceeding 4 hours in the air for the purposes of Clause 4, and 4 star accommodation for the purposes of Clause 6 of Determination Number 178 – ‘Travel allowances for full-time and part-time office holders’; and

2. Determination Number 178 is varied by deleting reference to ACT Insurance Authority Board and inserting ACT Insurance Authority Advisory Board in Schedule A under Part-Time Public Offices.

This Determination shall take effect on 4 July 2005.
