Part-time Holder of Public Office

Independent Reviewer, Government Campaign Advertising

Background

Section 10 of the *Remuneration Tribunal Act 1995* (the Act) requires the Remuneration Tribunal (the Tribunal) to inquire into, and determine, the remuneration, allowances and other entitlements to holders of the positions mentioned in Schedule 1 of the Act or notified in writing to the Tribunal by the Chief Minister for the purposes of this section.

The Chief Minister has referred the Independent Reviewer, Government Campaign Advertising to the Tribunal for such determination.

The Independent Reviewer is a statutory position established under the *Government Agencies (Campaign Advertising) Act 2009* and will be required to review proposed government campaigns to ensure they comply with the Act.

Tribunal Consideration

The Tribunal considered that it was appropriate to set remuneration at the higher end of the existing daily rates for part-time holder of public office.

The Tribunal determined remuneration at \$670 per diem, with effect from 7 June 2010.

Under section 10 of the *Remuneration Tribunal Act 1995* the Remuneration Tribunal has inquired into the remuneration, allowances and other entitlements to be paid to the Independent Reviewer, Government Campaign Advertising.

The Tribunal has determined as follows:

1. That Attachment A of Determination Number 17 of 2009 made in November 2009 be varied by inserting the following: -

2. Economy class travel for the purposes of Clause 4, and 3 or 3.5 star accommodation for the purposes of Clause 6 of Determination Number 16 of 2007 – ‘Travel allowances for full-time and part-time holders of public office’; and

3. Determination Number 16 of 2007 is also varied by inserting Independent Reviewer, Government Campaign Advertising in the Schedule under Part-Time Public Offices.

This Determination shall take effect on the date of this determination.
