## Statement Number 154

### Part-Time Holders of Public Office

#### Community Inclusion Board

#### Background

Sub-section 10(1)(r) of the *Remuneration Tribunal Act 1995* provides for the Tribunal to inquire into, and determine, the remuneration and allowances to be paid, and other entitlements to be granted to a person holding an office or appointment, or a class of offices or appointments, specified in an instrument given to the Tribunal by the Chief Minister.

The Chief Minister has referred the offices of Chair and members of the Community Inclusion Board to the Tribunal.

The Board is a non-statutory body that is required to develop strategies for dealing with the causes of social exclusion, provide expert advice and recommendations to Government, monitor the implementation of the Government's poverty proofing initiative and liaise with the Joint Community Government Reference Group.

The Board is the peak advisory body for the Implementation Strategy identified in the Canberra Social Plan.

#### Tribunal Consideration

The Board is fundamental to the implementation of the Social Plan and it is anticipated that it will have a significant impact on the immediate and long-term development and wellbeing of the community. It is a high profile body.

The Board will meet at least quarterly, with all members being required to perform substantial out of hours session work, including work on sub-committees specialising on aspects of social policy.

The Tribunal compared the responsibilities of the members to positions on other boards and committees.

#### Tribunal Decision

The Remuneration Tribunal considered that the Board fits into Group 2, Level 1 of the Tribunal's classification criteria, that is, 'Significant advisory boards and other bodies advising Government on key strategic matters AND/OR operation of significant Government programs.'

The Tribunal has determined that remuneration be set at \$30,000 per annum for the Chair and \$10,000 per annum for Members.

The date of effect is 18 May 2004.

### Community Inclusion Board

#### The Tribunal determines as follows:

Pursuant to subsection 10(1)(r) of the *Remuneration Tribunal Act 1995* the Remuneration Tribunal has inquired into the remuneration and allowances to be paid, and other entitlements to be granted to persons holding public office in the Community Inclusion Board and determines as follows: -

1. That Attachment 1 of Determination Number 133 made on 18 December 2003 be varied by inserting the following in Group 2, Level 1: -

2. Economy class travel for the purposes of Clause 4 and 4 star accommodation for the purposes of Clause 6 of Determination Number 110 – ‘Travel allowances for full-time and part-time office holders’; and
3. Determination Number 110 is varied by inserting ‘Community Inclusion Board, Chair and Members’ in Schedule A under Part-Time Public Offices.
