Part-Time Holders of Public Office

ACT Skills Commission

Background

Section 10 of the *Remuneration Tribunal Act 1995* provides for the Tribunal to inquire into, and determine, the remuneration and allowances to be paid, and other entitlements to be granted to persons appointed to certain Part-Time Public Offices.

The Chief Minister has referred the non- statutory offices of Chair and Members of the ACT Skills Commission for such determination.

Tribunal Consideration

The Tribunal compared the responsibilities of the members to positions on other boards, committees and tribunals.

Tribunal Determination

The Tribunal decided that the ACT Skills Commission should be located in Group 4, Level 3 of the Tribunal's classification criteria, that is, 'Advisory/consultative bodies to Departments and advisory committees considering local matters'.

The Tribunal has determined that remuneration be set at \$370 per diem for the Chair and \$310 per diem for Members.

The date of effect of the Determination is 30 November 2006, the date of the referral by the Chief Minister.
