Statement Number 128

Part-Time Holders of Public Office

Background

Paragraph 10(1)(t) of the *Remuneration Tribunal Act 1995* provides for the Tribunal to inquire into, and determine, the remuneration and allowances to be paid, and other entitlements to be granted, to a person holding an office or appointment, or a class of offices or appointments, specified in an instrument given to the Tribunal by the Chief Minister.

The Tribunal recently considered appropriate remuneration and allowances for the Chairman, Deputy Chairman and Members of the Land Development Board of the new Land Development Agency. The Agency was created with the Planning and Land Authority under the *Planning and Land Act 2002*.

In respect of the Chairman, the Tribunal determined an amount of \$50,000 per annum for the first twelve months of the Board's operation and \$45,000 per annum from 1 July 2004. In the case of Members, the amounts were \$25,000 and \$30,000 respectively. The initial amount reflected the additional work that would be required in setting up the Land Development Agency.

In order to accommodate the amounts, it is necessary to vary the Determination 109 – Part-time Holders of Public Office by increasing the maximum entitlement in Group 1, Level 1.

Tribunal Decision

The remuneration range in Group 1, Level 1 of Attachment 1 to Determination 109 be varied by the increasing the maximum amounts from \$40,000 to \$65,000 for the Chairman and from \$25, 000 to \$30,000 for Members.

The date of effect of the Determination is 20 May 2003.
